Dear Assemblywoman Jasey,

We represent the Executive Committee of the South Orange-Maplewood Special Education Parents Advisory Committee (SEPAC). We are writing to you in your capacities as our representative, as a Co-Chair of the Assembly's Joint Committee on the Public Schools, and as someone who knows our district well, having served on its Board of Education. We are contacting you about a topic that we care deeply about and pay close attention to – state school funding, particularly for special education.

We are all parents of special needs students in the South Orange-Maplewood School District. While we are grateful for the great teachers and strong support our children have had over the years, we are concerned that increasing budget constraints, including continued under-funding by the State of New Jersey, threaten the quality of education that our children are entitled to under the law.

Over the past several years, our District has been forced to make significant cuts to special education teaching staff and programs, and needed services have been harder and harder to obtain. On our current path, we will soon be in a crisis, and some of our most vulnerable students will be hardest hit by it.

It is with great disappointment that we see continued under-funding of education in New Jersey, particularly in Districts like ours. We understand that for 2014-2015, South Orange-Maplewood is receiving just 57% of state education funding it should be due under a full (capped) SFRA funding scenario. That puts our District in the bottom 15% of all districts on percentage of full (capped) funding. These funding shortfalls, along with limitations in our district's ability to raise local taxes given that they are already astronomically high and fund 90% of our school budget, are severely hurting our students.

We realize that money is tight everywhere. But we also realize that education funding is an investment in our State's future. Under-investing in our greatest resource, our young people, might make for short term fiscal gains, but it does not bode well for the long term success of our State.

We urge you to do whatever you can to assure full, or at least substantially increased, SFRA funding as soon as possible – using the allocations as intended by the legislature in 2008 when the law was passed.

We look forward to hearing your thoughts and ideas on this important topic.
